#### Transportation and Custodial Vacancies

## **Building Reports**

District administrators were pleased to report to the board that over 120 students are currently participating in summer school. Additionally, building administrators discussed details, revisions and additions to the building handbooks. The board approved building handbooks for the 2022-2023 school year.

## **District Operations**

With regard to District Operations:

- The board approved Property and Casualty Insurance Renewal with KERMP, Kansas Educational Risk Management Services.
- Last fall, due to the sale of Otho properties and the decrease in assessed valuation, the district made adjustments to the MIL rates levied for the 2021-2022 budget. These adjustments were made to avoid a significant increase to taxes paid by community members. As expected, these adjustments require a transfer from the contingency fund to other school budget funds. The board approved the transfer of up to \$300,000 from the contingency fund.
- Tim Austin, project manager for Iron Horse Development in Wichita, proposed a plan to acquire property currently owned by the district. While no transaction was approved, the board requested further details regarding a possible agreement.
- The board approved an agreement with the Cherokee County Arts Association (CCAA) to provide a fall musical for our students. The fall of 2022 performance will be the 1950's Broadway musical comedy *Guys and Dolls*.
- The board was updated on the current efforts of district administrators to meet the requirements of SB 2567 to post a district needs assessment.
- The district's initial ESSER III application has passed initial, secondary and Commissioner's Task Force review. The application is on the state board of education's agenda for approval on Tuesday, June 14.
- The board began initial conversations regarding clarification and possible revisions to Policy KG regarding use of school facilities by non school organizations.

- the hiring of Alison Williams as a part time custodian
- a leave request for a custodial staff member.
